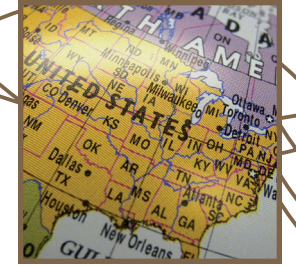

What is the EB-5 Program?

Congress created the Employment-Based Fifth (EB-5) Immigrant Investor Green Card Program in 1990. The purpose of the EB-5 program is to encourage immigrants to invest in, or manage U.S. companies that benefit the U.S. economy.

If you wish to immigrate to the U.S. and are willing to invest \$500,000, you and your family (spouse and any children under 21) can receive a “conditional” green card good for two years.

After two years, if you have maintained the investment and created at least ten jobs, the conditional status is removed and you become a “permanent” green card holder. After five years you are eligible for U.S. Citizenship if desired.

As an EB-5 immigrant, you may either invest in your own company, or in a fund that invests your money (along with other EB-5 immigrants) in qualified projects.

General Questions

1. What is the United States Citizenship and Immigration Service (USCIS)?

USCIS is a government agency responsible for the administration of immigration and naturalization functions and establishing immigration services and policies. On March 1, 2003, the U.S. Immigration and Naturalization Service (INS) merged with the Department of Homeland Security (DHS) to form USCIS.

2. How many EB-5 visas does the USCIS allot each year?

The EB-5 program, administered by the USCIS, allots 10,000 visas per year for aliens (and their families) whose investment creates or preserves at least ten full-time jobs for U.S. workers. 3,000 of these visas are set-aside for aliens who invest through Regional Centers such as the Milwaukee Regional Center.

3. Must I have previous business experience or education?

No, you do not need any prior business experience. You are not required to demonstrate any minimum level of education. The only requirement is that you have the investment capital, and proof that the funds are legal.

4. Do I need to speak English?

You do not need to know any English to live or work in the United States.

5. What makes this program different from the L-1 Manager Transfer or E-1 Treaty Trader or E-2 Treaty Investor programs?

The EB-5 program gives you permanent resident status. The E-1 and E-2 programs offer non-immigrant status only, because when your investment ends, so does your non-immigrant status. The L-1 program is a non-immigrant classification, but allows you to apply for classification as a Multinational Executive or Manager (which is becoming more difficult due to a tighter review process) and eventually, Permanent Resident status.
